Step 1: Vehicle Purchase

Step 2: Submission of Application

Submit Form 20 along with the required documents at the respective Rajasthan RTO. Applications can be initiated online and completed offline depending on the service type.

Step 3: Vehicle Inspection

The RTO inspector physically verifies the vehicle, including:

- Chassis number
- Engine number
- Vehicle category and compliance

This step ensures authenticity and prevents fraudulent registrations.

Step 4: Payment of Registration Fees and Taxes

You must pay:

- Registration fees
- Road tax (lifetime tax for private vehicles)

The amount depends on vehicle type, fuel type, engine capacity, and cost.

Step 5: Number Allocation

Once verified, the RTO assigns a registration number. You may choose:

- A standard registration number
- A fancy or VIP number (subject to availability and additional charges)

Step 6: Issuance of Registration Certificate (RC)

After approval, the Registration Certificate (RC) is issued. It may be provided digitally first, followed by a smart card RC sent to your registered address.

Vehicle Registration Fees in Rajasthan

Registration fees vary based on vehicle category:

- Two-wheelers: Lower registration and road tax
- Cars (private): Based on vehicle cost and fuel type
- Commercial vehicles: Higher fees and periodic tax

Electric vehicles often enjoy reduced or zero road tax as per state policies.

Time Taken for Vehicle Registration

Typically, the registration process at a Rajasthan RTO takes **7 to 15 working days**, provided documents are complete and there are no discrepancies. Online dealer-facilitated registrations are often faster.
